1. Conflict of Interest

At the start of the meeting, the Chief Executive reminded members about procedures for dealing with any potential conflict of interest arising during a board meeting:

The ETB Act of 2013 and the Code of Governance (2019) both state that a member of an ETB board must absent himself/herself when the board is deliberating or deciding on matters in which that member has an interest. He/she should not take any part in any deliberation of the board relating to the matter, should not influence, or seek to influence, a decision to be made in relation to the matter and should not vote on a decision relating to the matter.

2. Election of Chairperson and Deputy Chairperson

As per schedule 3 (3) of the Education and Training Boards Act 2013, every education and training board shall elect one of its members to be chairperson of such a board. Peter Cleere was nominated and elected as Chair as proposed by Mary Hilda Cavanagh, seconded by Ger Frisby and agreed.

The Chair then took up his position and presided at the meeting. The Chair thanked the Board for their confidence in him as chair and indicated that he was looking forward to working with the board over the next number of years.

The Chair's first duty was to facilitate the election of a Deputy Chairperson as per Schedule 3(4) of the Education and Training Boards Act 2013. As proposed by Patrick O'Neill, seconded by Michael Delaney and agreed, Mary Hilda Cavanagh was nominated and elected as Deputy Chairperson.

7. Chief Executive's Report

Chief Executive Eileen Curtis delivered the Chief Executive's report.

The CE noted that as this was the first business meeting of the newly formed board, a number of additional items are included for discussion as part of the agenda.

7.1 Corporate Governance and Administration

Board Induction

- A Board Member Induction Pack, which is focused on many aspects of governance and risk, had been prepared and was presented to each Board member.
- Members were asked to reflect on the material and informed that an induction briefing would take place at the November board meeting.

 Board members were requested to sign a confirmation of receipt of the information to ensure compliance with KCETB's requirement to provide members with such information on their appointment.

Governance Training

A programme of governance training for Education and Training Boards is currently being developed by Crowe Ireland, an audit and business advisory firm. The programme is provided by the Department of Education and Skills and managed by ETBI.

The training focuses on Good Governance Practices to the Education and Training Board Sector in conjunction with the roll out of the Code of Practice for the Governance of Education and Training Boards 2019.

Training modules will be provided for the following groups in 2019:

- · Chairpersons of ETB Boards
- Chief Executives
- Chairpersons of Finance Committees
- Chairpersons of Audit and Risk Committees
- Directors of Organisation Support and Development

Training for all board members will be conducted in each ETB region during the first six months of 2020.

Training will run on a workshop basis and focus on the practicalities of achieving governance responsibilities.

Governance Policies and Procedures

Kilkenny Schools Campus: Land exchange with St. Kieran's College, Kilkenny

It is proposed to exchange parcels of land with St. Kieran's College, Kilkenny to facilitate the provision of a new secondary school and a new Gaelcholáiste in Kilkenny City.

Independent valuations on both sites have confirmed that they are of equal value.

Board approval to dispose of the land in question is required under Section 12 (2) (n) of the Education and Training Boards Act 2013 and Section 8 of the Code of Practice for the Governance of Education and Training Boards 2019.

The Board approved KCETB to seek Ministerial approval for these transactions as proposed by Caitlín Mhic Cárthaigh, seconded by Mary Hilda Cavanagh and agreed.

The 2018 Annual Report has been cleared for publication.

Annual Financial Statements

The audited financial statements for 2018 have been signed off by the C&AG. These can now be included in the Annual Report and published on the ETB website.

7.2 Schools

Director of Schools, Pauline Egan presented the schools report.

Teaching and Learning

- All schools and centres recommenced for the 2019/2020 academic year in late August.
- Leaving Certificate results were of a very high standard across schools and centres and staff are congratulated on their hard work.
- The Student of the Year Awards for 2018/2019 will take place on 6 September.
- Teaching and Learning Workshops a series of workshops to enhance teaching and learning will continue during the academic year. Youthreach and VTOS staff are included in this training. The workshops focus on practical workshops to improve classroom teaching and learning.

Governance and Management of Schools

- Olivia Kennedy takes up the post of Acting Principal in Borris Vocational School for the academic year 2019/2020. An Acting Deputy principal will be appointed in due course.
- Training workshops are scheduled for Student Council members.
- 85 new teaching appointments have been made for the 2019/2020 academic year.
- Microsoft SharePoint is being rolled out across schools.
- Tyndall College and Carlow Institute of Further Education and Training began the new academic year in their state-of-the-art facilities.

Coláiste Aindriú

The focus continues to be on the recruitment of new students and on the promotion of the school in the local community. The Board also acknowledged the hard work by the staff of Coláiste Aindriú and KCETB in their commitment to increasing enrolment year on year.

The Board expressed their delight that the new campus in Carlow is open for the start of the academic year.

7.3 Further Education and Training

Director of Further Education and Training, Martha Bolger presented the FET report.

KCETB was awarded capital funding for the following projects (funded by DCYA):

- Carlow Regional Youth Service
- Ossory Youth

The Tullow Youth Project was launched, led by Carlow Regional Youth Services, the project is funded through KCETB by DCYA.

KCETB participated in a DEASP INTREO Employer Briefing in August, a national event for employers to demonstrate INTREO services.

Skills to Advance (run through Training Services) currently have a number of programmes running, as part of the SOLAS Employee Development Strategy – "Supporting Working Lives and Enterprise Growth in Ireland"

KCETB attended the IVERK Show to promote the availability of courses and will attend the National Ploughing Championships.

QQI visited KCETB in May, the visit provided the opportunity for positive engagement since the formal re-engagement with QQI in 2018.

It is intended that learners who wished to take part in cancelled outreach programmes will be facilitated on other programmes.

It was clarified to the Board that the PLSS form is a requirement of SOLAS and DES, concerns regarding the form will be relayed to SOLAS.
